In consideration of Havasu Mobility Scooters LLC provision of equipment to Customer and the covenants hereunder, the parties agree as follow:

\_\_\_\_\_ 1. **INSPECTION AND TRAINING** – The party signing below as Customer acknowledges he/she has had an opportunity to personally inspect the equipment and finds it suitable for their needs and is in good condition, and that he/she understands its proper operation.

\_\_\_\_\_ 2. **REPLACEMENT OF MALFUNCTIONING EQUIPMENT** – If the equipment becomes unsafe or in disrepair as a result of normal use, Customer agrees to discontinue use and notify Havasu Mobility Scooters LLC who will then replace or repair the rental equipment if available.

\_\_\_\_\_ 3. **PROHIBITED USES** – Use of the equipment in the following circumstances is prohibited and constitutes a breach of this contract:

- a) illegal purposes,
- b) using when in disrepair,
- c) improper, unintended use or misuse,
- d) food or drinks NOT allowed on equipment,
- e) step inclines/downgrades/gravel/ and or soft sand,
- f) use at any location other than the address furnished without Havasu Mobility Scooters LLC express permission in advance.

\_\_\_\_\_ 4. **TIME OF RETURN** – Customer’s right to possession terminates on the expiration of the rental period and retention of possession after this time without a new agreement constitutes material breach of contract. Any extension must be mutually agreed upon in writing.

\_\_\_\_\_ 5. **LATE RETURN** – Customer agrees to return the equipment during Havasu Mobility Scooters LLC normal business hours upon termination of the rental period. If not returned in a timely manner, Customer shall pay the additional rental charges.

\_\_\_\_\_ 6. **DAMAGED EQUIPMENT** – Customer agrees to pay for any damages to or the loss of equipment regardless of cause, except reasonable wear and tear while the equipment is out of possession of Havasu Mobility Scooters LLC. Accrued rental charges cannot be applied against the purchase or cost of repair(s) of any damaged or lost equipment therefore a security deposit of \$100 per unit will be paid by the customer and held by Havasu Mobility Scooters until termination of this agreement. The cost of repairs will be borne by customer whether performed by Havasu Mobility Scooters or others. Customer will be charged \$10.00 per key if not returned.

\_\_\_\_\_ 7. **CONSENT AND RELEASE** – Customer understands his/her rights and responsibilities and voluntarily consents to have Havasu Mobility Scooters LLC provide the stated equipment, and furthermore, releases Havasu Mobility Scooters LLC and its directors, officers, representatives, employees, agents, successors, and assigns from all legal responsibility and liability for any injuries or property damage caused by the improper, unauthorized, and/or negligent use of this equipment.
